

REQUEST FOR BIDS:

JANITORIAL SERVICES FOR CITY HALL

Notice is hereby given that the City of Fort Stockton is accepting sealed bids from individuals interested in providing Contractual Janitorial Services for the City of Fort Stockton; on a daily basis; 5 days weekly after 6:00 p.m. Offices include City Hall, City Hall Annex, and Police Department. **Bid amounts can be submitted for City Hall or Police Department/City Hall Annex or as a complete package for the three (3) buildings.**

The individual(s) awarded the bid(s) must provide sufficient personnel to effectively manage the required duties to maintain a clean office environment for each building. Eligibility to work in and around the buildings will be determined by the City Manager. Individuals being considered for this Contractual Service will be subject to an extensive background check.

Contractor(s) Shall Perform General Cleaning Tasks Daily &/or As May Be Required:

- **Interior & Exterior Areas:** Carpet/spot cleaning, vacuuming, damp mopping, sweeping, waxing/buffing floors, interior cleaning of all furnishings, glass and stainless steel cleaning, spot cleaning of walls, thorough cleaning of the breakroom and restrooms, trash removal, interior/exterior windows, etc.
- **The Contractor(s) shall furnish all of the required cleaning products and janitorial equipment.**

Repeated failure to meet performance expectations may result in termination of the contract. Contractors are prohibited from bringing unauthorized children or persons to work.

The approved and accepted bid will be awarded during the Regular City Council Meeting scheduled for Tuesday, August 22, 2017.


