

ORDINANCE NO. 18-130

AN ORDINANCE AMENDING THE ZONING CHAPTER OF THE MUNICIPAL CODE OF THE CITY OF FORT STOCKTON, TEXAS, ALLOWING FOR THE PLACEMENT OF A DOUBLE-WIDE MANUFACTURED-MOBILE HOME BY SPECIFIC-USE PERMIT IN A SINGLE FAMILY- 4 (SF-4) RESIDENTIAL DWELLING DISTRICT; ON LOT FOUR (4), BLOCK ONE HUNDRED EIGHTY ONE (181), ORIENT ADDITION; &/OR ADJACENT TO ST. GALL STREET, FORT STOCKTON, PECOS COUNTY, TEXAS, AS REQUESTED BY PROPERTY OWNER ROSARIO HURTADO & IN ACCORDANCE WITH SECTION 7(1), 7(2) & 7(16) OF THE ZONING ORDINANCE AND PROVIDING FOR AN EFFECTIVE DATE PROVISION.

WHEREAS, a petition for allowing the placement of a Double-Wide Manufactured-Mobile Home in a Single Family-4 (SF-4) Residential Dwelling District by Specific-Use Permit, as allowed in Sections 7(1), 7(2) & 7(16), Appendix B of the Zoning Ordinance has been duly presented to the City Council of Fort Stockton, Pecos County, Texas by Property Owner Rosario Hurtado, Fort Stockton, Texas; &

WHEREAS, the same petition was also presented to the Planning and Zoning Commission of the City of Fort Stockton; &

WHEREAS, a Public Hearing was held by the Planning and Zoning Commission on August 15, 2018 and City Council on August 28, 2018 after due notice by a newspaper publication as provided by the Zoning Ordinance Procedure.


NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT STOCKTON, PECOS COUNTY, TEXAS:

SECTION 1. That Section 7(1), USE REGULATION DISTRICTS. 7(2) PRIMARY RESIDENTIAL USES & 7(16), SPECIFIC-USE PERMITS, is hereby amended:


TO ALLOW FOR THE PLACEMENT OF A DOUBLE-WIDE MANUFACTURED-MOBILE HOME BY SPECIFIC-USE PERMIT IN A SINGLE FAMILY - 4 (SF-4) RESIDENTIAL DWELLING DISTRICT; ON LOT FOUR (4), BLOCK ONE HUNDRED EIGHTY ONE (181), ORIENT ADDITION, AS ALLOWED IN THE ZONING ORDINANCE.


SECTION 2. DATE OF EFFECT: This Ordinance shall be in effect immediately upon its adoption and publication as provided by law.
