

**RE-SOLICITATION OF REQUEST FOR
LEASE PROPOSALS**

Notice is hereby given that the Fort Stockton City Council is accepting proposals for leasing of:

APPROXIMATELY 274 ACRES OF LAND LOCATED ON T&P RR CO. BLOCK 3, SECTION 71 IN PECOS COUNTY, TEXAS. THIS PROPERTY CONTAINS THE CITY OF FORT STOCKTON WASTEWATER TREATMENT PLANT SERVING THE TEXAS DEPARTMENT OF CRIMINAL JUSTICE AND THREE (3) REGISTERED WATER WELLS WITH 960 ACRE FEET OF H&E IRRIGATION PERMITS.

EVERY PROPOSAL THAT IS SUBMITTED SHALL CONTAIN THE FOLLOWING RESTRICTIONS:

- The City of Fort Stockton shall have priority to use all water wells located on the property and can curtail all irrigation use of the water wells; as well as all treated effluent water;
- The City of Fort Stockton shall have the right to amend all H&E Permits for Municipal and Public Use Supply for Water Rate Payers in Pecos County;
- The City of Fort Stockton shall have the right to limit the amount of treated effluent water supplied to the lessee to comply with its TCEQ Permit;
- The Lessee shall be required to take and dispose of all treated effluent water supplied to the lessee to comply with the City of Fort Stockton TCEQ Permit; &
- The Lessee shall authorize the City Water Attorney and City Manager to submit permits to Middle Pecos Groundwater Conservation District who will approve rules.

Every proposal that is submitted must include **Lease Term, Yearly Lease Payment, and Business Plan for the Use of Property.**

Sealed proposals will be received **no later than 10:00 a.m. on August 22, 2019** in the Office of the City Secretary; at which time they will be opened publicly and read aloud. The approved and accepted lease proposal will be awarded at the Regular City Council Meeting scheduled for **August 27, 2019 @ 5:30 P.M.**


