Chief of Police Robert Lujan stated that morale at the Police Department was high. He stated June 15th & 16th the 911 Dispatch would be moving to the New Police Department. June 22nd & 23rd Tri-Star would move the Dispatch Equipment over to the New Police Department.

SECOND ORDER OF BUSINESS:

2. City Manager Frank Rodriguez III— City Manager's Report

City Manager Rodriguez advised City Council that the Gas Department did not have any findings during their audit conducted 2 weeks ago.

Gas Superintendent Marcos Tovar updated City Council on the status of the Valero Crossing Project. He explained in accordance with the Railroad Commission Guidelines the City is required to have a minimum of 0.85 volts going through the pipe to help prevent corrosion.

He stated the City was previously getting readings of 0.671.

He explained the purpose of the Valero Crossing Project was to dig up the pipe, sand blast it, re-coat it, hook it up with new anodes and a rectifier with the correct voltage to help prevent the corrosion.

He informed City Council that 300 ft. of pipe were dug up, sand blasted and recoated. He further explained that the project was supposed to include the treatment of additional pipe; however, this treatment has the Valero Crossing's current readings at 0.9, which is well within the required voltage.

Therefore, the price difference between the estimated cost and the actual cost can be attributed to the amount of pipe treated.

Gas Superintendent Tovar clarified that there were no violations on the Operators Qualifications Manual during the recent audit.

Director of Public Works Aaron Ramos explained that 12 sealed bids were submitted before the 10:00 a.m. deadline on June 3, 2020; none of which were local contractors.

The 3 lowest bids were as follows: J.C. Roberts Construction Company, Inc. from Midland, Texas with a bid of \$1,356,494.50, Onyx Contractors Operations, LP from Midland, Texas with a bid of \$1,285,723.32 and Stephenson Dirt Contracting from Mount Pleasant, Texas with a bid of \$1,268,946.26.

JC Roberts Construction

- Has 20 full-time employees
- Does not have experience working on Landfill Infrastructure; however, they have employees who have experience working on Landfill Infrastructure Projects with other companies.

Approximately 28% of the work will be performed by the contractor. The remainder of the work will be sub-contracted.

Onyx Contractors Operations, LP

Has 90 full-time employees

- Has experience working on Landfill Infrastructure Projects. Since 2000 they have worked on and completed 13 Landfill Infrastructure Projects in West Texas & Texas Panhandle areas.
- Approximately 77% of the work will be performed by the contractor. The remainder of the work will be sub-contracted.

Stephenson Dirt Contracting

- Has 30 full-time employees
- Does not have experience working on Landfill Infrastructure Projects. Has similar experience building frac and water ponds/pits in the oilfield business.
- Approximately 90% of the work will be performed by the contractor. The remainder of the work will be sub-contracted.

He explained after a thorough review of the bids submitted, Hanson Engineering recommended the contract be awarded to Stephenson Dirt Contracting.

He stated all references had favorable comments.

Public Works Director/Chief Landfill Operations Manager Ramos recommended Onyx Contractors Operations, LP. After a review of the lowest 3 proposals submitted, he stated Onyx Contractors Operations, LP was the only contractor with experience performing and completing Landfill Infrastructure Projects similar to the scope of work our project would consist of. They also have the most full-time employees and would perform 77% of the work themselves. Their bid was for \$1,285,723.32.

City Manager Rodriguez explained that the City has the right to select the lowest bid or any of the other companies. He and Public Works Director Ramos noticed that some of the local businesses were trying to assist some of the contractors that submitted a proposal.

Council Member Falcon inquired if J.C. Roberts Construction Company, Inc. was going to sub-contract 90% of the work.

Public Works Director Ramos responded that J.C. Roberts Construction Company, Inc. would perform 28% of the Project. They would sub-contract 70% of the project. Should J.C. Roberts Construction Company, Inc. be awarded the project a local business would conduct 60% of the project.

Council Member Falcon inquired if Stephenson Dirt Contracting would subcontract 10% of the project, if awarded.

Public Works Director Ramos verified that Stephenson Dirt Contracting would sub-contract 10% of the project.

Council Member Falcon recalled that Onyx Contractors Operations, LP was the only Contractor with Landfill Infrastructure experience similar to what the City of Fort Stockton needs. He inquired if they would be doing the majority of the work themselves.

Public Works Director Ramos replied that Onyx Contractors Operations, LP would conduct 77% of the work themselves.

Council Member Falcon pointed out the 5-strand barbed-wire fence for Onyx Contractors Operations, LP was much higher than the other contractors.

Council Member Warnock attributed the difference in price to the fence being brought in from somewhere else.

Council Member Casias inquired if J.C. Roberts Construction Company, Inc. would sub-contract approximately 70% of the work to local contractors.

Public Works Director Ramos responded that JC Roberts will sub-contract 60% of the excavation to a local contractor.

Council Member Falcon and Council Member Casias emphasized the importance of the City of Fort Stockton helping their own economy.

Mayor Alexander agreed with Council Member Falcon and Council Member Casias; however, he recalled the great job Hanson Engineering did with the 30-inch Waterline Project. He stated he felt confident in their recommendation for Stephenson Dirt Contracting.
